**TO GUARANTEE YOUR SQUAD TIMES**

**YOUR ENTRIES WITH PAYMENT MUST BE RECEIVED NO LATER THAN JAN 31**

Entries will be taken up to one hour before squad times, provided lanes are available.

A \$5.00 fee will be charged per person per event for walk-ins.

## TOURNAMENT RULES

1. All current league members (2017-2018) of the Suburban Windy City USBC are eligible to enter if they are not under suspension from the United States Bowling Congress and meet all other eligibility rules.
2. No memberships will be sold at the tournament site. All members **MUST** be certified prior to entering the tournament.
3. Entrants may bowl on more than one team. Not more than two members of a team can be the same in order for a team to place more than once in the standings. Entrants may bowl on multiple doubles teams but can only place once in the standings with the same partner. Entrants are eligible to bowl more than once in the singles division, but can only place once in the standings. 1st series bowled in each event will be used to total all event scores. Only two PBA members per team, and one PBA member per doubles.
4. **Doubles and singles can now be bowled at separate times. They are separate events. However, you may bowl them together, just mark the same squad for both.**
5. **All bowlers on a senior team must be 55 years of age or older.**
6. Entrants must use the highest sanctioned league average of 21 games or more from the 2016-2017 season or composite average as shown on bowl.com (whichever is higher), including summer. If no 2016-2017 average, they can use the highest current sanctioned league average with 21 games or more. If using the current league average, a copy of the bowler's individual average page must accompany the entry form. Unattached cardholders or league members with no established average will be given a 220 average. A composite average, as shown on BOWL.com if higher, may also be used. **If any average is from a Sport League (also known as Tough Shot and PBA Experience), Challenge, or established on sport patterns, tough shots, international patterns, whether the league is certified/sanctioned or not, it must be reported and will be adjusted as per the USBC conversion chart. Use of this average for entry may be denied.**
7. USBC rule 319 will be enforced in its entirety. All bowlers are subject to re-rating. A bowler is required to report any previous tournament rerate/adjustment.
8. The handicap for the handicap and senior divisions will be 90% of: Team 2640, Doubles 1320, Singles 660. If your team average is higher than 2640, your doubles average is higher than 1320, or your singles average is higher than 660, you will be entered in the scratch division.
9. Prize money will be returned 100% in prizes. One prize for each seven (7) entries (or major fraction) will be given.
10. **\*\* BONUS EVENTS \*\*:**
  - a. **BONUS TEAM SINGLES:** If you opt for this when entering Team event, the individual 3-game set that you bowl during the Team event is used for a separate singles prize fund. Handicap will be added for the handicap division.
  - b. **DOUBLES BONUS:** If you opt for this when entering Singles and Doubles event, the individual 3-game set that you bowl during the Doubles event is used for a separate singles prize fund. Handicap will be added for the handicap division.
  - c. **DOUBLES COMBINE:** Doubles and Singles only. When opting for combine, both your 3-game Doubles score and 3-game Singles scores are combined for a 6-game total for a separate prize fund. Handicap will be added for the handicap division.
11. Any person who bowls under an assumed name, is under suspension from the Congress or submits a false average will be disqualified and, if not already so, be liable for suspension. Likewise, any team or individual knowingly employing a person herein described shall have their scores disqualified and will be subject to suspension.
12. All decisions of the Tournament Manager are final.

**NO refunds after bowling date is scheduled - no team will be entitled to a refund after the entry blank and fees have been received and definite dates assigned or it is discovered that some team or individual has failed to comply with all Suburban Windy City USBC or United States Bowling Congress eligibility requirements. The Tournament Director of the Suburban Windy City USBC may refuse to permit any team or individual to bowl if it is determined that the entry should not have been accepted.**
