## TOURNAMENT RULES

1. All current adult league members (2024-2025 season) of the Suburban Windy City USBC with a minimum of 21 games in a SWC certified league are eligible to enter if they are not under suspension from the United States Bowling Congress and meet all other eligibility rules.
2. Entrants must use the highest certified league average of 21 games or more from the 2023-2024 season as shown on **bowling.com**, including summer leagues, or the composite average if higher. If no 2023-2024 average, they can use the highest current certified league average with 21 games or more. If using the current league average, a copy of the bowler's individual average page or current standing sheet must accompany the entry form. League members with no established average will be given a 200 average. **If any average is from a Sport League (also known as Tough Shot and PBA Experience), Challenge, or established on sport patterns, tough shots, international patterns, whether the league is certified or not, it must be reported and will be adjusted as per the USBC conversion chart. Use of this average for entry may be denied.**
3. USBC rule 319 will be enforced in its entirety. All bowlers are subject to re-rating. A bowler is required to report any previous tournament re-rate/adjustment.
4. The handicap will be 90% of: 200.
5. Prize money will be returned 100% in prizes. One prize for each seven (7) entries (or major fraction) will be given.
6. Any person who bowls under an assumed name, is under suspension from the USBC or submits a false average will be disqualified and, if not already so, be liable for suspension. Likewise, any team or individual knowingly employing a person herein described shall have their scores disqualified and will be subject to suspension.
7. If no contact email address is given then a confirmation will not be sent.
8. If no home center is given, the hosting center will be used. All decisions of the Tournament Manager are final.
9. **\*\* BONUS EVENT \*\***
  - a. **SCRATCH BONUS:** Singles only. If you opt for this, the 3 game set is used for a separate singles scratch prize fund.
